Notice of Availability

This Notice of Availability (NOA) has been prepared to notify agencies and interested parties that the Orange County Sanitation District (OCSD), as the Lead Agency has prepared a Draft Program Environmental Impact Report (Draft PEIR) pursuant to the California Environmental Quality Act (CEQA), to provide the public and responsible agencies with information about the potential effects on the local and regional environment associated with the proposed Biosolids Master Plan, Project No. PS15-01 (BMP or proposed program).

The proposed program includes upgrades to and construction of new biosolids handling facilities to be implemented over a 20-year planning period. The nine individual projects that would be implemented under this BMP would provide for flexible and sustainable biosolids handling to accommodate increased wastewater treatment for the future. Proposed projects include: (1) southwest perimeter screening at Plant No. 2; (2) an interim food waste receiving facility at Plant No. 2; (3) the relocation of an existing warehouse on Plant No. 2; (4) the relocation of an existing collection yard from Plant No. 2 to Plant No. 1; (5) the construction of a temperature phased anaerobic digestion (TPAD) digester facility at Plant No. 2 that includes six new digesters, pump station, ultrafiltration/nanofiltration facilities, sludge cooling heat exchangers, a power building, electrical control rooms, six new Class A batch tanks and a digester feed facility; (6) relocation of the existing ferric chloride facility and demolition/redevelopment of four existing digesters and Power Building C at Plant No. 2; (7) an ultimate food waste receiving facility at Plant No. 2; (8) demolition of seven existing digesters and the addition of three digesters/holders with associated facilities such as pumps, pipelines, heat exchangers, and grinders at Plant No. 2; and (9) the demolition of the six existing digesters at Plant No. 2.

Public Review and Comments: OCSD is soliciting comments from the public regarding the content of the Draft PEIR prepared for the proposed program. The Draft PEIR will be used by OCSD when considering approval of the proposed program. OCSD has established a 45-day review period that begins **February 14**, **2018** and ends **April 2, 2018**.
