## Greg Sebourn of Fullerton and David Shawver of Stanton to serve as Chairman and Vice-Chairman for the Orange County Sanitation District

**Fountain Valley, California** – The Orange County Sanitation District (OCSD) announces that Fullerton City Council Member Greg Sebourn will serve as Chairman for the OCSD Board of Directors. This position was previously held by City of Tustin, Mayor Pro Tem John Nielsen. David Shawver, with the City of Stanton will serve as Vice-Chairman.

"I'm grateful for the respect and confidence that my colleagues have shown me as Chairman of this world class organization," stated Greg Sebourn. "It is my hope to continue what my predecessor John Nielsen started by moving OCSD to 100 percent recycling. The Orange County Sanitation District is more than a wastewater agency, we are a resource recovery agency, and I will do my best to continue to support my fellow board members and the staff in the mission of this agency to protect the public health and the environment."

The 25-member Board is comprised of one county supervisor, 20 city council members, two sanitary district and two water district representatives.

Mr. Sebourn has served on the OCSD Board for four years where he most recently served as the Board Vice-Chairman. Additionally, Sebourn participates on a variety of OCSD committees including the Legislative and Public Affairs Committee, Operations Committee, Administration Committee, and the Steering Committee.

Mr. Sebourn is an Associate at the Orange County office of Stantec Consulting Services Inc., a global Architectural and Engineering firm. He has worked on many notable projects including the subdivision of Anaheim Stadium to make room for an NFL expansion team, U.S. border properties and rights-of-way acquisition, several National Forest survey projects, and numerous smaller municipal projects. He holds Associate of Science Degrees in Administration of Justice from Fullerton College and Survey/Mapping Sciences from Santiago Canyon College.
